

Proud to Be an American! By Rick DiBartolomeo

Back in March, I had the privilege and honor of being selected as a Distinguished Visitor (DV) of the United States Navy. As a DV, I



along with eleven other DV's spent a day onboard the USS Theodore Roosevelt (TR). The TR is a Nuclear Powered, Nimitz Class U.S. Naval Aircraft Carrier whose active service began in October 1986. The TR is a 97,000 ton floating city of 5,500 men and women from

every state in the Union. The TR is a key element of our country's forward-deployed defense strategy. Tasked with maintaining open sea lanes of trade and communications, TR is capable of projecting air superiority to all points of the globe. The TR was about 100 miles off the coast of Virginia when we "hooked a line" and landed on the flight deck in our Navy transport plane. For the next 24 hours, I and the other DV's

witnessed first hand, the long hours that these young men and women of our country put in each and every day.

We spent time (both day and night) on the flight deck and in the tower watching planes land and get catapulted off. We had lunch with the sailors, dinner with the Captain and his officers, midnight rations (mid rats) with the pilots and were able to walk around (escorted) and talk with the sailors.

Probably the most rewarding part of the visit was to be able to show our appreciation to the sailors for all that they do. The IACC, along with several other organizations, friends and family donated money, gas cards, phone cards, gift certificates, etc. which in turn were passed out to the sailors. To see the look on their faces! You would have thought it was Christmas Day. The majority of these men and women are 19-22 years old and do not make a lot of money. The phrase, "Thank you, sir" was repeated several times during our visit. I could not have asked for a more rewarding experience.

As we prepared to be catapulted off the ship, the men and women on the flight deck saluted us and wished us a safe trip. I saluted back and said to myself, I am proud to be an American!








